Polasaí Iontrála don Idirbhliain do chuairteoirí

1. Foirm iarratais iomlán a líonadh amach, le grianghraf.
2. Dhá thuairisc scoile is déanaí ón scoil reatha.
3. Aon thuairisc siceolaíochta maidir leis an bpáiste.
4. Agallamh le tuismitheoirí agus an dalta.
5. Síntiús scoile a bheith díolta

Coimeádann Meánscoil San Nioclás an ceart:

6. Tuairisc a lorg ó scoil an dalta
7. Diúltú do dhalta **ag aon phointe roimh 1 Meán Fómhair**, má tá mí-iompar in scoil eile i gceist.

Beidh tréimhse phromhaidh ag gach cuairteoir Idirbhliana. **Más léir don scoil nach bhfuil éthos na Meánscoile oiriúnach don dalta roimh 30 Meán Fómhair, caithfidh na tuismitheoirí an páiste a bhreith leo go dtí scoil éigin eile.** Is é gnó an tuismitheora a chinntiú go bhfuil soláthar déanta don bhféidearthacht san roimh ré.

Tá sé de dhualgas ag tuismitheoirí a chur in iúl don Mheánscoil má bhí/tá cás maidir le míiompar, bíodh sé beag nó mór, curtha i leith a bpáiste.

Is don Idirbhliain amháin a bheidh seasamh ag na daltaí ar chuairt bhliana chugainn.

Má theastaíonn ó dhalta fuireach sa scoil don gcúrsa Ardteiste, (agus má tá fáil ar áit sa rang-ghrúpa), seo a leanas an próiséas:

1. Foirm iarratais ‘Aistriú’ a líonadh amach roimh Cháisc na bliana reatha.
2. Déanfaidh bainistíocht na scoile iniúchadh ar iompar agus ar dhul chin cinn an dalta.
3. Beidh agallamh leis na tuismitheoirí agus leis an dalta.
4. Tabharfar cinneadh i scríbhinn gan a bheith níos déanaí ná 30 Aibreán.

Enrolment policy for visitors to the Transition Year

1. Application form fully completed with passport size photograph.
2. Two most recent school reports supplied
3. Any psychological report provided
4. An interview with the parents and the child
5. Payment for the TY account made

Meánscoil San Nioclás reserves the right:

6. To inquire into the student's behaviour in their current school at any time.
7. To refuse admission to the Transition Year **at any point before September 1**, based on the student's behaviour in their current school.

There will be a probationary period for all visiting students. **If the ethos of the Meánscoil proves unsuitable for the child before September 30, they must be removed from the school.** Parents must ensure that they have made provision for this possibility.

Parents are required to inform Meánscoil San Nioclás if their present school has any issue regarding their child's behaviour.

Enrolment in Meánscoil San Nioclás for the Transition Year applies only to that year.

If a pupil wishes to stay in the school for 5th and 6th Year (and if a place is available in the class group), the following is the process:

1. The form 'Transfer of a Pupil' must be completed before Easter of the current year.
2. The school management will inquire into the behaviour of the pupil and of their academic progress during the year.
3. The parents and the student will be interviewed.
4. A decision will be given in writing no later than April 30 of the current year.
