

Polasaí Scáileáin

Is féidir le múinteoir cead a thabhairt do dhaltaí fearas le scáileán (guthán, ipad, ipod, camera 7rl.) a úsáid **taobh istigh den seomra ranga**, má tá gá leis, do mhodhanna múinte an ranga.

Féachfaidh an múinteoir agus an dalta chuige go múchfar na scáileáin **sula n-imíonn na daltaí ón seomra ranga**.

Má tá cúis go dteastaíonn ó mhúinteoir an scáileán a bheith in úsáid taobh amuigh de dhoras an tseomra, bíodh cead scríte go sonrach (lá agus am) i Dialann Scoile an dalta.

Moltar do dhaltaí a bheith ar a n-aire agus an fearas a bheith i bhfolach go sábhálta arís chomh luath is a bhíonn an tréimse críochnaithe. Beidh an dalta féin freagrach as a threallamh pearsanta.

Ná dearúdfar go bhfuil cead ag Bliain 5+6 a ríomhairí glúine féinig a úsáid ag aon am.

Níl aon athrú ar na rialacha ginearálta maidir le húsáid guthán/scáileán/treallamh digiteach.

A teacher may give permission to pupils to use equipment with screens (phone, ipad, camera etc.) within the classroom walls, if required for teaching methodologies.

Bl.5 + 6 may use laptops at their own discretion in school.

N.B. There is no change to the general rules regarding use of phones and digital equipment in the school.

Úsáid Chóir do scáileáin agus taifead d'aon tsaghas

Má dhéantar taifead fuaime nó físe le cead múinteora ar scoil, nó mar ghnó scoile ag aon am:

Níl cead an taifead sin ná aon chuid de, a eisiúint ar aon tsuíomh idirlín in aonchor seachas suíomh na scoile agus níl cead é a sheoladh chun cinn go dtí aon pháirtí eile.

Má tá cead eisceachtúil ag teastáil ag dalta ó aon mhúinteoir chun obair a eisiúint, bíodh an cead sin faighte i scríbhinn (is leor r-phost) ón bpríomhoide.
